

Texas Resident Students Not Eligible to File 2020-2021 FAFSA

Students who qualify under one of the following citizenship/immigration statuses should file the Free Application for Federal Student Aid (FAFSA) online at www.fafsa.ed.gov:

- U.S. Citizen
- U.S. Permanent resident with an Alien Registration Card (I-551)
- Conditional U.S. permanent resident with visa type I-551C.
- Eligible noncitizen with an Arrival/Departure Record (I-94) showing one of the following codes: Refugee (RF), Asylum granted (AS), Parolee (DT) (for a minimum of one year), or Cuban-Haitian entrant (CH).

If none of these apply to you but you are classified as a Texas resident (meaning you would be eligible to pay the in-state tuition rate at a Texas public college), you should submit the Texas Application for State Financial Aid (TASFA) and the other documents below to TCU.

- 1. A paper copy of the **TASFA Application** is attached. You can also fill this form out online and print it to submit to TCU Financial Aid. Go to www.collegeforalltexans.com and click on the left picture "Students." Next, click on FINANCIAL AID on the left menu. In the first bulleted sentence on that page, click on the words "financial aid application." On the following page, scroll down and click on the 2020-2021 TASFA Application (available in English or Spanish).
- 2. Complete the attached **Texas Core Residency Questionnaire** and return to TCU Financial Aid.
- 3. Complete the attached **Affidavit** and submit to TCU Financial Aid.
- 4. Submit all of the following Income Verification documents to TCU Financial Aid.
 - Copy of 2018 IRS Tax Return transcript for student and parent(s). To order a tax transcript, go to www.irs.gov/individuals/get-transcript or call 1-800-908-9946
 - B. Copy of **2018 W-2's for student and parent(s).**
- 5. Selective Service: All male students must submit to TCU Financial Aid a valid selective service registration number or copy of the selective service registration card. You can register for selective service at www.sss.gov, or print the verification if you have already registered.

The Texas Application for State Financial Aid (TASFA) collects information to help determine eligibility for state (or institutional) financial aid programs administered by institutions of higher education in the state of Texas. Students classified as Texas Residents who are not eligible to apply for federal financial aid using the Free Application for Federal Student Aid (FAFSA) are encouraged to complete the TASFA. To review the FAFSA filing requirements, visit www.fafsa.ed.gov or visit the financial aid office at the institution you plan to attend for the 2020-21 award year. **Note:** The federal application covers federal **and** state financial aid opportunities. If you meet the FAFSA filing requirements, then you should submit a completed FAFSA. You do not need to complete both the FAFSA and TASFA.

The Texas state priority deadline for many institutions of higher education is **January 15, 2020** for the 2020-21 award year. It is recommended that applicants complete and submit this application and any other required documentation to the financial aid office on or before January 15. **Note:** Texas residency and final eligibility for financial aid can only be determined by the institution that you plan to attend.

To complete this application, answer each item within the applicable sections. For clarification on specific items, refer to the **TASFA Notes on pages 6-8**. If you have further questions, contact the financial aid office at your institution.

These notes provide clarification to various questions on the TASFA. The peach items indicate a student (and spouse) response is needed, and the purple items indicate a parent response is needed. If you need additional assistance, contact the institution's financial aid office that you currently attend or plan to attend for the 2020-21 award year.

SECTION ONE: STUDENT INFORMATION

Notes for questions 5 and 6 (page 1)

Question 5. If you have been issued a social security card, enter your assigned number. If you have been approved for Deferred Action of Childhood Arrivals (DACA), enter your assigned social security number (SSN) through this program. If you don't have an assigned SSN, mark N/A.

Question 6. Enter your ID number issued by your college or university, if applicable.

Notes for question 24 (page 2)

Enter your gender at birth.

Individuals who were born male are required to complete a **Selective Service Statement of Registration Status** and either be registered with Selective Service or be exempt from registration to be eligible for state financial aid (TEC, Section 51.9095). If you are male and between the ages of 18 through 25, you can register by visiting <u>www.sss.gov</u> or completing a registration form found at a U.S. Post Office. If you are over the age of 25, you can no longer register. Male students over the age of 25 who knowingly and willfully failed to register with Selective Service are not eligible for state financial aid.

Selective Service Statement of Registration Status

- If you marked I am under the age of 18 and not currently required to register: Contact your current institution to confirm whether additional proof is required.
- If you marked I am REGISTERED with the Selective Service, and your current institution does not have proof of your registration on file: You must submit documentation to your current institution in order to be eligible for state financial aid.
- If you marked I am EXEMPT from registration, and your current institution does not have proof of your exemption on file: You must submit documentation to your current institution in order to be eligible for state financial aid.
- If you marked I am over the age of 18. I am not registered with Selective Service and I am not exempt from registration with Selective Service, then you may not be eligible for state financial aid. Contact your current institution to discuss your eligibility status.

Notes for question 25 (page 2)

If you have been convicted of a felony or a crime involving a controlled substance (e.g., drugs, alcohol), enter "Yes."

If "**Yes**," see your institution's financial aid office regarding additional documentation that may be requested (e.g., confirmation of eligibility).

Notes for question 27 (page 2)

- **A.** Texas College Work-Study (TCWS) is a state program that provides employment positions to eligible students with financial need.
- B. If you have been approved for Deferred Action of Childhood Arrivals (DACA), you could be eligible for the Texas College Work-Study Program. Your college will require proof of your authorization to work in the U.S. (e.g., copy of your SSN card).

Notes for questions 28 and 29 (page 2)

Question 28. Report your marital status as of the date you sign your TASFA (enter married if you are separated but not divorced). If your marital status changes after you sign your TASFA, check with your financial aid office at your institution.

Question 29. Enter the month and year of the status selected in question 28. If you have never been married, remarried, separated, divorced, or widowed, mark "N/A."

Notes for question 30 (page 2)

If you were born on January 1, 1997, you should enter "No."

Notes for question 35 (page 2)

Enter "Yes" if at any time since you turned age 13:

- You had no living parent (biological or adoptive), even if you are now adopted;
- You were in foster care, even if you are no longer in foster care today; or
- You were a dependent/ward of the court, even if you are no longer a dependent/ward of the court today.

If you are not sure if you were in foster care, check with your state's child welfare agency. You can find that agency's contact information at <u>www.childwelfare.gov/nfcad</u>.

Notes for questions 36 and 37 (page 2)

The definition of legal guardianship does not include your parents, even if they were appointed by a court to be your guardians. You are also not considered a legal guardian of yourself.

Enter **"Yes"** if you can provide a copy of the court's decision that as of today you are an emancipated minor or are in legal guardianship. Also, enter **"Yes"** if you can provide a copy of a court's decision that you were an emancipated minor or were in legal guardianship immediately before you reached the age of being an adult in Texas. The court must be located in your state of legal residence at the time the court's decision was made.

Enter **"No"** if you are still a minor and the court decision is no longer in effect or the court decision was not in effect at the time you became an adult. The financial aid administrator at your school may require you to provide additional information such as a copy of the court's decision.

Notes for questions 38-40 (page 2)

Enter **"Yes"** if you received a determination at any time on or after July 1, 2019, that you were an unaccompanied youth who was homeless or at risk of being homeless.

- Homeless means lacking fixed, regular, and adequate housing, which includes living in shelters, motels, or cars, or temporarily living with other people because you had nowhere else to go.
- Unaccompanied means you are not living in the physical custody of your parent or guardian.
- Youth means you are 21 years of age or younger or you are still enrolled in high school as of the day you sign this application.

Answer **"No"** if you are not homeless or at risk of being homeless, or if you do not have a determination. You should contact your financial aid office for assistance if you do not have a determination but believe you are an unaccompanied youth who is homeless or are an unaccompanied youth providing for your own living expenses who is at risk of being homeless.

SECTION THREE: PARENT INFORMATION

Notes for questions 41-56 (page 3)

Question 41 and 43-56. Report your legal parents' marital status as of the date you sign your TASFA (enter married if they are separated but not divorced). If your parents' marital status changes after you sign your TASFA, check with your financial aid office at your institution.

- If your parent was never married and does not live with your other legal parent, select "**Never Married.**" If your parent is widowed and not remarried, select "**Widowed.**" In these two cases, only answer questions 43-49.
- If your legal parents (biological, adoptive, or as determined by the state [for example, if the parent is listed on the birth certificate]) are not married to each other and live together, select "Unmarried and both parents living together" and answer questions 43-56 about both parents regardless of their gender. Do not include any person who is not married to your parent and who is not a legal or biological parent.
- If your legal parents are married, select "Married or remarried." If your legal parents are divorced but living together, select "Unmarried and both parents living together." If your legal parents are separated but living together, select "Married or remarried," not "Divorced or separated." Answer questions 43-56 about both parents.
- If your legal parents are divorced or separated, select "Divorced or separated," and answer questions 43-49 about the parent you lived with more during the past 12 months. (If you did not live with one parent more than the other, give answers about the parent who provided more financial support during the past 12 months or most recent year that you received support from a parent.) If this parent is remarried as of today, select "Married or remarried," and answer questions 43-56 about that parent and your stepparent.

Question 42. Enter the month and year of your parents' marital status selected in question 41. If your parents have never been married, remarried, separated, divorced, or widowed, mark "N/A."

In general, a person may be considered a dislocated worker if he or she:

- is the spouse of an active duty member of the Armed Forces and has experienced a loss of employment because of relocating due to permanent change in duty station; or
- is the spouse of an active duty member of the Armed Forces and is unemployed or underemployed, and is experiencing difficulty in obtaining or upgrading employment; or
- is a displaced homemaker. A displaced homemaker is generally a person who previously provided unpaid services to the family (e.g., a stay-at-home mom or dad), is no longer supported by the spouse, is unemployed or underemployed, and is having trouble finding or upgrading employment.
