

# **Texas Resident Students Not Eligible to File 2022-2023 FAFSA**

Students who qualify under one of the following citizenship/immigration statuses should file the Free Application for Federal Student Aid (FAFSA) online at www.fafsa.ed.gov:

- U.S. Citizen
- U.S. Permanent resident with an Alien Registration Card (I-551)
- Conditional U.S. permanent resident with visa type I-551C.
- Eligible noncitizen with an Arrival/Departure Record (I-94) showing one of the following codes: Refugee (RF), Asylum granted (AS), Parolee (DT) (for a minimum of one year), T-Visa holder (T-1, T-2, T-3, etc.) or "Cuban-Haitian Entrant," or the holder of a valid certification or eligibility letter from the Department of Health and Human Services showing a designation of "Victim of human trafficking.".

Suppose none of these apply to you, but you are classified as a Texas resident (meaning you would be eligible to pay the in-state tuition rate at a Texas public college). In that case, you should submit the Texas Application for State Financial Aid (TASFA) and the other documents below to TCU.

- 1. A paper copy of the **TASFA Application** is attached. You can also fill this form out onlineand print it to submit to TCU Financial Aid. Go to www.collegeforalltexans.com and click on the left picture "Students." Next, click on FINANCIAL AID on the left menu. In the first bulleted sentence on that page, click on the words "financial aid application." Scroll down and click on the 2022-2023 TASFA Application (available in English or Spanish) on the following page.
- 2. Complete the attached **Texas Core Residency Questionnaire** and return it to TCU Financial Aid.
- 3. Complete the attached **Affidavit** and submit it to TCU Financial Aid.
- 4. Submit all of the following Income Verification documents to TCU Financial Aid.
  - A. Copy of 2020 IRS Tax Return Transcript for student and parent(s).

  - B. Copy of 2020 W-2's for student and parent(s).

# **Texas Application for State Financial Aid**

The Texas Application for State Financial Aid (TASFA) is a free application that collects information to help determine eligibility for state (or institutional) financial aid programs administered by institutions of higher education in the state of Texas. Students classified as Texas residents who are not eligible to apply for federal financial aid using the Free Application for Federal Student Aid (FAFSA) are encouraged to complete the TASFA. To review the FAFSA filing requirements, visit <u>fafsa.gov</u> or contact the financial aid office at the institution you plan to attend for the 2022-23 award year. **Note:** The federal application covers federal **and** state financial aid opportunities. If you meet the FAFSA filing requirements, then you should submit a completed FAFSA. You do not need to complete both the FAFSA and TASFA.

The state financial aid priority application deadline for many institutions of higher education is **January 15, 2022** for the 2022-23 award year. In order to be considered for the most financial aid that may be available to you, it is important to complete and submit this application with all required documentation to the financial aid office **on or before Jan. 15. Note:** Texas residency and final eligibility for financial aid can only be determined by the institution that you plan to attend.

To complete this application, answer each item within each section. If a question does not apply to you, answer N/A for not applicable. For clarification on certain items, refer to the TASFA Notes on pages 6-8. If you have further questions about this form, contact the financial aid office at your institution. Some institutions have an online version of the TASFA; check with your institution before filling out the pdf or paper version. Note: Personal information collected on the TASFA is protected under the Family Educational Rights and Privacy Act (FERPA) of 1974.

# **Texas Application for State Financial Aid**

These notes help explain certain questions on the TASFA. The blue items indicate a student (or spouse) question, and the purple items indicate a parent question. Contact the financial aid office at the institution you currently attend or plan to attend for the **2022-23** award year if you need additional assistance completing this application.

# **SECTION ONE: STUDENT INFORMATION**

#### Notes for questions 5 and 6 (page 1)

**Question 5.** If you have been issued a social security card, enter your assigned number. If you have been approved for Deferred Action for Childhood Arrivals (DACA), enter your assigned social security number (SSN) through this program. If you do not have an assigned SSN, mark "N/A."

**Question 6.** Enter your ID number issued by your college or university, if applicable.

#### Notes for question 24 (page 2)

Enter your gender at birth. Individuals who were born male are required to complete a **Selective Service Statement of Registration Status** and either be registered with Selective Service or be exempt from registration to be eligible for state financial aid (<u>Texas Education Code (TEC)</u>, <u>Title 3</u>, <u>Section 51.9095</u>). If you are male and between the ages of 18 through 25, you can register by visiting <u>www.sss.gov</u> or completing a registration form found at a U.S. Post Office. If you are over the age of 25, you can no longer register. Male students over the age of 25 who knowingly and willfully failed to register with Selective Service are not eligible for state financial aid.

#### **Selective Service Statement of Registration Status**

- If you marked I am under the age of 18 and not currently required to register: Being under 18 and not yet registered does not impact your ability to receive financial aid for the academic year. Contact your current institution to confirm whether additional proof is required.
- If you marked I am REGISTERED with the Selective Service, follow up with the institution you plan to attend to see if anything additional is needed.
- If you marked I am EXEMPT from registration, please explain the reason why you are exempt from the federal registration requirement. For more information on the requirement, visit www.sss.gov.
- If you marked I am over the age of 18. I am not registered with Selective Service and I am not exempt from registration with Selective Service, then you may not be eligible for state financial aid. Contact your current institution to discuss your eligibility status.

Enter "Yes" if at any time since you turned age 13:

- You were a dependent/ward of the court, even if you are no longer a dependent/ward of the court today.

#### Notes for questions 36 and 37 (page 2)

The definition of legal guardianship does not include your parents, even if they were appointed by a court to be your guardians. You are also not considered a legal guardian of yourself.

Enter "Yes" if you can provide a copy of the court's decision that as of today you are an emancipated minor or are in legal guardianship. Also, enter "Yes" if you can provide a copy of a court's decision that you were an emancipated minor or were in legal guardianship immediately before you reached the age of being an adult in Texas. The court must be located in your state of legal residence at the time the court's decision was made.

Enter "No" if you are still a minor and the court decision is no longer in effect or the court decision was not in effect at the time you became an adult. The financial aid administrator at your school may require you to provide additional information such as a copy of the court's decision.

#### Notes for questions 38-40 (page 2)

Enter "Yes" if you received a determination at any time on or after July 1, 2021, that you were an unaccompanied youth who was homeless or at risk of being homeless.

- Homeless means lacking fixed, regular, and adequate housing, which includes living in shelters, motels, or cars, or temporarily living with other people because you had nowhere else to go.
- Unaccompanied means you are not living in the physical custody of your parent or guardian.
- Youth means you are 21 years of age or younger or you are still
  enrolled in high school as of the day you sign this application.

Answer "No" if you are not homeless or at risk of being homeless, or if you do not have a determination. You should contact your financial aid office for assistance if you do not have a determination but believe you are an unaccompanied youth who is homeless or are an unaccompanied youth providing for your own living expenses who is at risk of being homeless.

# **SECTION THREE: PARENT INFORMATION**

## Notes for questions 41-56 (page 3)

**Note**: If you believe you have a special circumstance in which you are unable to enter parental information when completing the TASFA, **it is** important for you to notify and work closely with the financial aid office of the institution you plan to attend.

In limited circumstances such as the ones listed below, you may be able to submit your TASFA without providing parental information:

- Your parents are incarcerated.
- You have left home due to an abusive family environment.
- You do not know where your parents are and are unable to contact them (and you have not been adopted).

In these special circumstances, it is important for you to understand the following: The financial aid staff may ask for additional information to determine whether you can have an expected family contribution (EFC) calculated without parental data. Gather as much written evidence of your situation as you can. Written evidence may include court or law enforcement documents; letters from a clergy member, school counselor, or social worker; and any other relevant documentation that explains your special circumstance.

**Question 41 and 43-56.** Report your legal parents' marital status as of the date you sign your TASFA (enter married if they are separated but not divorced). If your parents' marital status changes after you sign your TASFA, check with your financial aid office at your institution.

- If your parent was never married and does not live with your other legal parent, or if your parent is widowed and not remarried, answer questions 43-49 about that parent.
