- Awards will not disburse to students account prior to 10 days before departure.
- Priority is given to upperclassmen, however all students are encouraged to apply.
- **This award is designated to tuition-only charges.**
- If you are receiving 100% VA funding, you are not eligible to receive this tuition award.
- You are not eligible for this funding if you complete your undergraduate program prior to departure for study abroad program.
- Applicants must be U.S. citizens or permanent residents.
- Study abroad grants may be used for summer 2020 only.
- Study abroad grants are one-time only awards; previous recipients of this award are not eligible.
- Funds awarded credit to the student's TCU account. It is the responsibility of the student to notify TCU Financial Services when requesting funds from their account. For more information, you may contact their office at (817) 257-7836.
- All requested information must be complete prior to the disbursement of funds. You may check the status of the information on your portal; my.tcu.edu
- LATE applications will be reviewed on a funds available basis.
